JUDGMENT SUMMARY

This matter was tried by a jury of twelve from October 13 to 22, 2014, the Honorable Samuel Chung presiding. Plaintiffs Robert and Jacqueline Piel appeared through their attorneys of record, Stephen M. Hansen, P.S. and Nealey Law (Stephen M. Hansen and Scott P. Nealey). Defendant City of Federal Way appeared through its attorney of record, the Summit Law Group PLLC (Shannon Phillips and Molly Terwilliger).

The parties presented evidence and testimony to the jury and on October 22, 2014, the jury returned a verdict in favor of the defendant on all claims. A copy of the jury's verdict is attached as exhibit A.


1 Consistent with the jury's verdict in this action, the Court enters final judgment in this
